COMPLAINT

Circuit City Stores, Inc. ("Circuit City"), by counsel, states as follows for its Complaint against Defendant John Doe, a.k.a. Speedy1961 ("Speedy1961"):

Nature Of The Case

1. Circuit City brings this action against Speedy1961 for damages and injunctive relief arising from Speedy1961's disclosure of Circuit's City confidential and proprietary information concerning its pricing of the Sony Playstation 3 video game console (the "PS3"), in violation of the common and statutory law of the Commonwealth of Virginia. Although Speedy1961 is presently unidentified, Circuit City intends to invoke the subpoena procedures found in Va. Code Ann. § 8.01-407 to obtain Speedy1961's identification and serve this action.

Parties and Venue

2. Circuit City is a Virginia corporation with its principal place of business in Henrico County at 9950 Mayland Drive, Richmond, Virginia 23233.

3. Circuit City is a national leader in the consumer electronics retail industry, with over 600 stores in at least 46 states. Circuit City sells a wide variety of consumer electronics and computers, as well as related goods and services.

4. Speedy1961 is an unknown individual who frequently posts communications to message boards on the websites CheapAssGamer.com ("CAG") and DVDTalk.com ("DVDTalk") using the user name "Speedy1961." Upon information and belief, Speedy1961 regularly posts early pre-release leaks of advertising from Circuit City, among other companies.

5. Venue over Circuit City's claims is proper under Virginia Code § 8.01-262(10), as Circuit City resides in Henrico County and the whereabouts of Speedy1961 are unknown.

Speedy1961's Disclosure of Circuit City's Confidential and Proprietary Information

6. On July 5, 2007, at approximately 2:23PM EDT, Speedy1961 posted a message to DVDTalk's "DVD Bargains" forum, entitled "Circuit City Prices: July 15 - July 21, 2007." This message disclosed the substance of Circuit City's Sunday newspaper advertising circular for the week of July 15. In pertinent part, Speedy1961 stated:

Good Day DVDTalkers and Circuit City watchers!

And a Special Shout Out To All My Friends at CAG!

I've got the Circuit City circular for 7/15/07 - 7/21/07 in my hands.

Please be aware of the following:

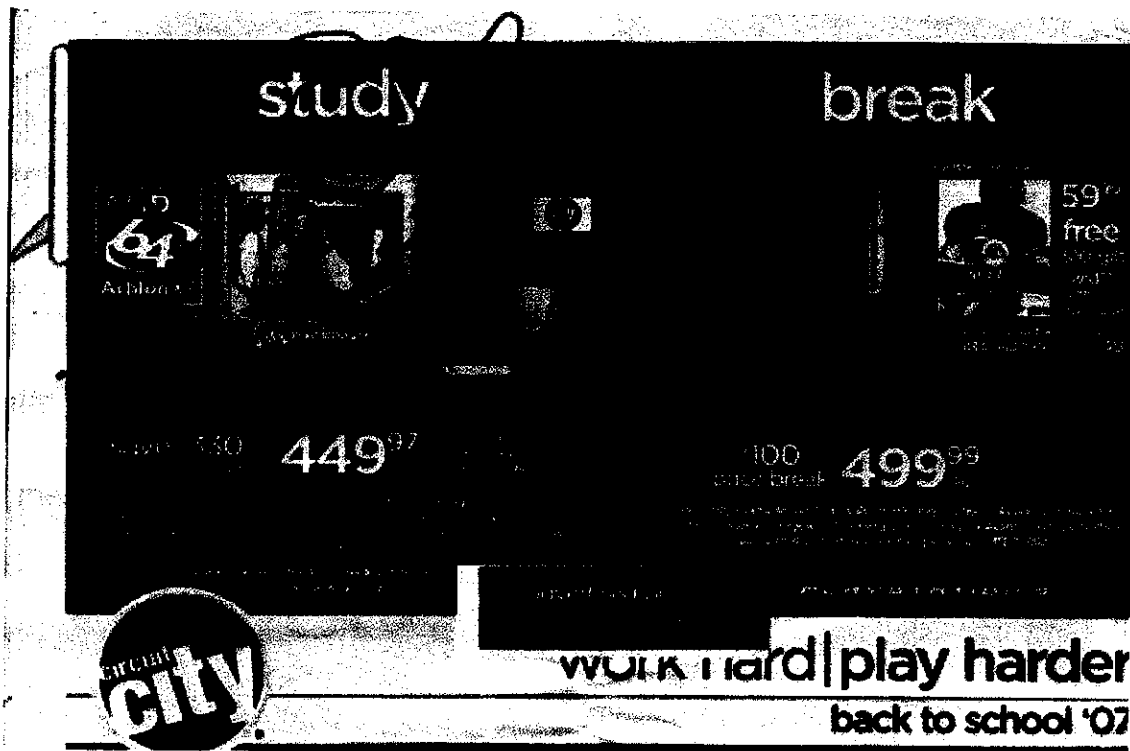

- ***GAMERS / MOVIE AFFICIANADOS: Please note \$100 Price Break on Playstation 3 Game System which brings the price down to \$499.99 . . .***

(emphasis added).

7. In other posts later in the same thread, Speedy1961 made clear that he was basing this information upon a copy of a Circuit City advertising circular that had yet to be released. Speedy1961 claimed that he had obtained the information in Tuesday, July 2, but had held it “as I thought it would be MAJOR news.”

8. At 5:00PM EDT on July 5, 2007, Speedy1961 posted a follow-up message to the same forum, containing an image that he indicated came from the Circuit City ad. That image is reproduced below:



9. Speedy1961 duplicated his actions later that day on the CAG website. At approximately 4:20PM EDT on July 5, Speedy1961 posted a message to CAG’s “Video Game Deals” forum entitled “Target/CC/Best Buy Prices: 7/15/07 - 7/21/07 ** Uber Thread **.” In part, this message stated:

Circuit City

Please be aware of the following:

* * *

- ***GAMERS / MOVIE AFFICIANADOS: Please note \$100 Price Break on Playstation 3 Game System which brings the price down to \$499.99 . . .***

(emphasis added). Again, Speedy1961 contended that his information was taken from a Circuit City advertisement he had received.

10. These posts disclosed highly confidential business information proprietary to Circuit City. The details of the Playstation 3 price break were highly confidential and, once disclosed by Speedy1961, spread like wildfire across the Internet well before that information was to be made public.

11. Price breaks are extremely important to the retail industry and Circuit City considers information about its planned sales events (including price breaks) to be confidential and proprietary until it appropriately releases that information. Circuit City was put at a competitive disadvantage by the unauthorized early release of this information by Speedy1961.

12. Speedy1961 clearly understands that his possession and disclosure of such confidential information is wrongful. In the thread of messages that followed Speedy1961's original posting to CAG, a poster known as "Daroga" asked: "Speedy, there's no chance you can get in trouble from this, can you?" Speedy1961 responded "There's always that possibility but useful knowledge must flow and not be 🙊."

13. In an earlier forum, a CAG member known as "MisterModest" asked forum users "Why is it such a big secret where [Speedy1961] gets the ads?" Speedy1961 responded "Simply put: It could cost me my job," adding "Not to mention potential lawsuits by the big 3 [Circuit City, Target and Best Buy] which happened to an employee of [Best Buy] who was 'leaking' info."

14. Speedy1961 refuses to disclose the source for his information. He has indicated from time to time on CAG forums that he receives copies of Circuit City advertising in his mailbox, but does not indicate whether this is an email mailbox or a traditional postal mailbox. However, when a CAG user known as "abhinav" speculated that Speedy1961 was receiving the ads from a postal employee, Speedy1961 responded "A little more complex than that but I am well connected (and apparently well liked in real life) so I have a 'helper' contact." In response to similar questioning from another poster, Speedy1961 answered "I'm well connected is all I can say."

15. Circuit City has made reasonable and diligent efforts to uncover Speedy1961's identity, to no avail. In posts to the CAG site, Speedy1961 has indicated that he posts "98.9% of these threads" from his workplace, that he uses internet access services provided by America Online and that he resides in Ansonia, Connecticut. Nothing else is known about Speedy1961's identity, and even the accuracy of these statements is unknown.

16. While Circuit City has no other reliable information concerning Speedy1961's identity, upon information and belief information tending to locate and/or identify Speedy1961 may be known to CAG Productions, LLC, ("CAG Productions"), a New York limited liability company that owns, operates and maintains the CAG website. Such information also may also be known to Kleinman.com, Inc., ("Kleinman"), an Oregon corporation that owns, operates and maintains the DVDTalk website.

17. Upon information and belief, neither CAG nor DVDTalk will disclose to Circuit City any information that might tend to identify Speedy1961 without first having received a subpoena or court order. Circuit City will promptly file and serve such a subpoena, pursuant to

Va. Code § 8.01-407.1, to obtain such information. As soon as Speedy1961's identity is disclosed to it, Circuit City will be able to amend this Complaint and serve Speedy1961.

COUNT ONE

Speedy1961's Breaches of Duties Owed to Circuit City

18. Circuit City incorporates by reference the allegations in paragraphs 1 through 17.

19. Before July 7, 2007, information concerning Circuit City's PS3 price break was known only to employees of Circuit City, Sony or the publishing companies that printed and distributed Circuit City's advertising circulars. Consequently, Circuit City believes that Speedy1961 may be a current or former employee. In the event that Speedy1961 is a current or former employee of Circuit City and is subject to Circuit City's arbitration program, then Circuit City intends to initiate an arbitration proceeding against Speedy1961.

20. To the extent Speedy1961 is a current or former employee of Circuit or a Circuit City vendor, Speedy1961 owes to Circuit City a continuing duty of loyalty, care, and confidentiality.

21. Through his actions, Speedy1961 has breached those duties of loyalty, care, and confidentiality to Circuit City.

22. Speedy1961's actions were knowing and intentional, and demonstrate a reckless, malicious and wanton disregard for Circuit City's rights.

23. Speedy1961's actions have required Circuit City to divert resources to investigating this matter. Moreover, by disclosing to Circuit City's customers and competitors confidential and proprietary sale information, Speedy1961 influenced sales behavior, making it less likely that a customer would purchase a PS3 from Circuit City between July 7 and July 15, when the price break goes into effect. Upon information and belief, this caused Circuit City to

lose a substantial amount of revenue. As a direct and proximate result of Speedy1961's breaches of duty, Circuit City has been damaged in an amount not yet ascertained, but in excess of \$15,000.

24. Unless and until Circuit City is able to discover Speedy1961's true identity and enjoin these improper activities, there remains the possibility of continued disclosure of confidential information, in further breach of Speedy1961's duties to Circuit City.

COUNT TWO

Speedy1961's Misappropriation of Trade Secrets

25. Circuit City incorporates by reference the allegations of paragraphs 1 through 17.

26. Virginia Code § 59.1-336, the Virginia Uniform Trade Secrets Act, protects the owner of trade secret information from the misappropriation and/or unauthorized disclosure of that trade secret information.

27. Details of Circuit City's PS3 price break was a trade secret at the time that Speedy1961 posted that information on DVDTalk and CAG. The information derived independent economic value from the fact that Circuit City's customers and competitors did not know the prices and rebates that Circuit City intended to offer in his July 15 advertising circular. Circuit City intended to maintain the secrecy of this information until the weekend of July 15. This information was highly confidential, and Circuit City took reasonable steps to safeguard its secrecy.

28. Upon information and belief, Speedy1961 acquired information concerning the PS3 price break in spite of the fact that Speedy1961 knew or had reason to know that the information was acquired by improper means.

29. Upon information and belief, Speedy1961 disclosed Circuit City's PS3 price break after acquiring it by improper means, or a time when Speedy1961 knew or had reason to know either that the information was derived from a person who had utilized improper means to acquire it, that the information was acquired under circumstances giving rise to a duty to maintain its secrecy, or that the information was derived from a person who owed a duty to Circuit City to maintain its secrecy.

30. Speedy1961 misappropriated information concerning Circuit City's PS3 price break in violation of Va. Code § 59.1-336 et seq. Upon information and belief, Speedy1961's misappropriation was willful and malicious.

31. Speedy1961's actions have required Circuit City to divert resources to investigating this matter. Moreover, by disclosing this trade secret Circuit City's customers and competitors, Speedy1961 influenced sales behavior, making it less likely that a customer would purchase a PS3 from Circuit City between July 7 and July 15, when the price break goes into effect. Upon information and belief, this caused Circuit City to lose a substantial amount of revenue. As a direct and proximate result of Speedy1961's breaches of duty, Circuit City has been damaged in an amount not yet ascertained, but in excess of \$15,000.

Prayer For Relief

WHEREFORE, Circuit City prays that this Court order, adjudge and decree:

(A) That Circuit City receive compensatory damages from Speedy1961 in an amount to be established;

(B) That Circuit City receive punitive damages from Speedy1961 in an amount to be established;

(C) That Circuit City recover from Speedy1961 its reasonable attorneys' fees and costs incurred in connection with this matter;


(D) That Speedy1961, Speedy1961's agents, employees, attorneys, and all persons in active concert with Speedy1961, be preliminarily and permanently enjoined from disclosing without authorization confidential information concerning Circuit City; and

(E) Such other and further relief as the Court deems just and proper.

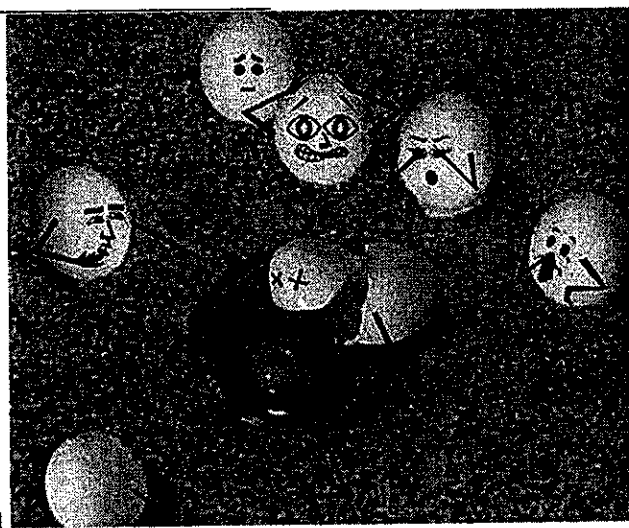
